# **REPORT OF THE SECRETARY-GENERAL** On the period October 1<sup>st</sup>, 2017 to October 1<sup>st</sup>, 2018

### **General Assembly**

On October 20th, 2017 the IFC held its 27<sup>th</sup> General Assembly in Jülich (Germany). All member organisations were present or were represented. The *Deutsche Gesellschaft für Festungsforschung* hosted the conference.

The day started with a tour of the Citadel, the Renaissance Palace and the town of Jülich. The next day a visit was made to a French fortification "Couronement de la Roër" (Brückenkopf) in Jülich and to a Prussian Fort "Zwischenwerk VIIIb" in Cologne.

### Presidency

President Andrea Theissen and Vice-President Luc Fellay were both at the end of their three years terms. The 27<sup>th</sup> General Assembly unanimously appointed Andreas Kupka as President of the International Fortress Council and Marc Gayda as Vice-President of the International Fortress Council. Their term ends in October 2020.

### **Multilingual Fortifications Dictionary (MFD)**


Jeroen van der Werf took over the responsibility for MFD from Maurice Lovisa. The MFDdrawings have been made by Chris Weber, who indicated to have finished this kind of work. So the IFC should look for other artists, when envisaging to enlarge the scope of the MFD.

EFFORTS, of which Menno van Coehoorn is a member, could be an instrument in obtaining EU-funds for this – per definition – multi-national project. Another option is to find a university that is familiar with this kind of projects. Jeroen van der Werf wants to digitalize the MFD, so one can search by name or category. He also suggests an addition to the current set-up: a large full-scale 'general picture' of the *model fortifications*, allowing zoom-in on particular details and in this way coming to the individual items and their particular names in the various languages.

After this addition, Jeroen suggests, we can go from the bastioned system to more periods, like the Polygonal system, etc.

Evert Westerhuis points out that A. von Zastrow already made this type of drawings for us.

### **Personal Data**

The Executive Board approved a declaration on personal data, as required by law of the country in which IFC is registered, i.e. the Netherlands. The secretariat is responsible for collecting and keeping personal data of organisations that are member of IFC. The secretariat follows the European General Data Protection Regulation, incorporated in the Netherlands Data Protection Regulation (*Algemene Verordening Gegevensbescherming*).



## Personal data

IFC collects data on representatives of member-organisations of IFC. The member-organisation implicitly agrees when supplying these data. Collected personal data are:

- Address of the member-organisation
- Telephone of the member-organisation
- Email address of the member-organisation
- Name of representatives of the member-organisation
- Telephone of the member-organisation's representative
- Email address of the member-organisation's representative

### Sensitive personal data

IFC has no intention of collecting data on visitors of IFC's website.

# What are personal data used for?

IFC collects personal data to:

- communicate with member-organisation through their designated representative(s)

### Automated decisions

IFC does not leave any decision-making to computers or by using computer programmes.

### How long personal data are stored

IFC keeps personal data as long as the organisation is member of IFC and the member-organisation has appointed its representative with IFC. After termination of a person's role as representative his personal data are immediately removed.

### Sharing personal data with third parties

IFC does not share personal data with third parties, unless obliged to do so under Netherlands law.

### **Cookies or comparable techniques**

IFC does not use cookies or comparable techniques.

### **IFC/CDSG Fortification Calendar**

The assembly expressed its appreciation of the "IFC/CDSG Forttours Calendar", and the Assembly thanked Terry McGovern for his work. The calendar is frequently renewed by Mr McGovern and is put on the website by the secretariat. Mr McGovern requests all IFC-members to send him information on activities/excursions, etc. At the last meeting of the Executive Board Dave Bassett reported on behalf of Terry McGovern that after visiting various IFC-members- websites he concluded that there are more excursions/events that are not reported to him and thus are not included in the CDSG/IFC Calendar.
